

CHAPTER 7
ORDINANCE CODIFICATION - DECEMBER 2002
TITLE I - ORGANIZATION & STRUCTURE

Jones County resolution readopting the existing county ordinances, as amended, into a county code of ordinances.

SECTION 1. PURPOSE

Code of Iowa Section 331.302, subsection nine, requires that at least once every five years, the board shall compile a code of ordinances containing all of the county ordinances in effect. This resolution adopts the code, as amended.

SECTION 2. READOPTION OF CURRENT ORDINANCES

The following ordinances have all been adopted and enacted into law since December 4, 2001 and were duly published as the law provides. All other ordinances previously adopted as provided by law are hereby readopted.

A. Jones County Ordinance 2002-01, amends and now becomes **CHAPTER 5, JONES COUNTY WASTEWATER RULES, of TITLE V - PUBLIC ORDER, SAFETY & HEALTH.**

B. Jones County Ordinance 2002-02, as amended by Jones County Ordinance 2002-05, now becomes **CHAPTER 6, JONES COUNTY TELECOMMUNICATIONS TOWERS AND ANTENNAS ORDINANCE, of TITLE VI - PROPERTY & LAND USE.**

C. Jones County Ordinance 2002-03, amends and becomes part of **CHAPTER 4, JONES COUNTY SUBDIVISION ORDINANCE, of TITLE VI - PROPERTY & LAND USE.**

D. Jones County Ordinance 2002-04, amends and becomes part of **CHAPTER 3, JONES COUNTY AGRICULTURAL LAND PRESERVATION ORDINANCE, of TITLE VI - PROPERTY & LAND USE.**

E. Jones County Ordinance 2002-06, amends and becomes part of **CHAPTER 7, JONES COUNTY NUISANCE ORDINANCE, of TITLE V - PUBLIC ORDER, SAFETY & HEALTH.**

F. Jones County Ordinance 2002-07, now becomes **CHAPTER 5, LOCAL OPTION SALES & SERVICES TAX, of TITLE II - PUBLIC SERVICES.**

G. Jones County Ordinance 2002-08, now becomes **CHAPTER 6, HOTEL & MOTEL TAX, of TITLE II - PUBLIC SERVICES.**

SECTION 3. CODE OF ORDINANCES

Copies of the code as adopted herein shall be on file and available for public inspection in the Jones County Auditor's Office.

SECTION 4. WHEN EFFECTIVE

This resolution shall be effective upon approval as provided by law.
