

CHAPTER 8
ORDINANCE CODIFICATION - DECEMBER 2003
TITLE I - ORGANIZATION & STRUCTURE

Jones County resolution readopting the existing county ordinances, as amended, into a county code of ordinances.

SECTION 1. PURPOSE

Code of Iowa Section 331.302, subsection nine, requires that at least once every five years, the board shall compile a code of ordinances containing all of the county ordinances in effect. This resolution adopts the code, as amended.

SECTION 2. READOPTION OF CURRENT ORDINANCES

The following ordinances have all been adopted and enacted into law since December 17, 2002 and were duly published as the law provides. All other ordinances previously adopted as provided by law are hereby readopted.

A. Jones County Iowa Ordinance 2003-01, amends and becomes part of **CHAPTER 3, JONES COUNTY AGRICULTURAL LAND PRESERVATION ORDINANCE, OF TITLE VI - PROPERTY & LAND USE.**

B. Jones County Ordinance 2003-02, replaces CHAPTERS 1 through 6, of TITLE II - PUBLIC SERVICES, and now becomes **CHAPTER 1, of TITLE II - PUBLIC SERVICES.**

C. Jones County Ordinance 2003-03, amends and becomes part of **CHAPTER 7, AREA SERVICE SYSTEM C ROAD CLASSIFICATION OF TITLE IV - STREETS, ROADS, PUBLIC WAYS & TRANSPORTATION.**

D. Jones County Ordinance 2003-04, amends and becomes part of **CHAPTER 5, THE ON-SITE WASTEWATER RULES OF TITLE V - PUBLIC ORDER, SAFETY & HEALTH.**

E. Jones County Ordinance 2003-05, now becomes **CHAPTER 9, ANIMAL PROTECTION AND CONTROL OF TITLE V - PUBLIC ORDER, SAFETY, & HEALTH.**

F. Jones County Ordinance 2003-06, amends and becomes part of the following chapters:

CHAPTER 3, UNIFORM RURAL ADDRESS SYSTEM, OF TITLE IV - STREETS, ROADS, PUBLIC WAYS, AND TRANSPORTATION;

CHAPTER 4, THE UTILITY INSTALLATION PERMIT ORDINANCE, OF TITLE IV - STREETS, ROADS, PUBLIC WAYS, AND TRANSPORTATION;

CHAPTER 5, THE JONES COUNTY SECONDARY ROAD SETBACK ORDINANCE, OF TITLE IV - STREETS, ROADS, PUBLIC WAYS, AND TRANSPORTATION;

CHAPTER 6, PROHIBITION FOR JUMPING AND/OR DIVING FROM COUNTY OWNED BRIDGES, OF TITLE IV - STREETS, ROADS, PUBLIC WAYS & TRANSPORTATION;

CHAPTER 1, HAZARDOUS SUBSTANCES, OF TITLE V - PUBLIC ORDER, SAFETY & HEALTH;

CHAPTER 5, THE ON-SITE WASTEWATER RULES OF TITLE V - PUBLIC ORDER, SAFETY & HEALTH;

CHAPTER 7, JONES COUNTY NUISANCE ORDINANCE, OF TITLE V - PUBLIC ORDER, SAFETY & HEALTH;

CHAPTER 8, JONES COUNTY LEAD ORDINANCE, OF TITLE V - PUBLIC ORDER, SAFETY & HEALTH;

CHAPTER 3, JONES COUNTY AGRICULTURAL LAND PRESERVATION ORDINANCE, OF
TITLE VI - PROPERTY & LAND USE;
CHAPTER 4, JONES COUNTY SUBDIVISION ORDINANCE OF TITLE VI - PROPERTY &
LAND USE;
CHAPTER 6, JONES COUNTY TELECOMMUNICATIONS TOWERS AND ANTENNAS
ORDINANCE, OF TITLE VI - PROPERTY & LAND USE.

SECTION 3. CODE OF ORDINANCES

Copies of the code as adopted herein shall be on file and available for public inspection in the Jones County Auditor's Office.

SECTION 4. WHEN EFFECTIVE
