The Jones County Board of Supervisors met in regular session. Present Supervisors Zirkelbach, Oswald, Schlarmann, Swisher, and Rohwedder.

Moved by Rohwedder seconded by Swisher to approve the minutes of the October 18, 2022 meeting. All aye. Motion carried.

Moved by Oswald seconded by Swisher to approve claims #2210-0164 through #2210-0380. All aye. Motion carried.

Moved by Swisher seconded by Rohwedder to open bids for Courthouse and Broadway Place snow removal at 9:05 a.m. All aye. Motion carried.

One bid was received from Dakota Starn, Timber Ridge Land Enhancement & Construction, for snow removal at 500 W. Main St., 105 Broadway Place, and 601 N. High St., Anamosa:

- \$200 per snow removal of drives and parking lots.
- \$200 per salt application.
- \$100 per removal of ice and/or snow from sidewalks at 105 Broadway Place.
- \$400 per removal of ice and/or snow from property perimeter sidewalks at 500 W. Main St. on an as requested basis.
- \$100 per truck load of snow to be hauled off premise on an as requested basis.

Moved by Swisher seconded by Schlarmann to award the snow removal bid to Dakota Starn, Timber Ridge Land Enhancement & Construction. All aye. Motion carried. [2022-169]

Moved by Rohwedder seconded by Schlarmann to void check #185738 in the amount of \$70.00, dated October 11, 2022, made payable to Iowa State County Treasurers Association; and corresponding claim #2210-0074, submitted by the Treasurer, with reason being the Treasurer is no longer able to attend the Leadership Retreat. Moved by Schlarmann seconded by Oswald to approve the hire of Ginger Taylor as Monticello Senior Dining Site Manager effective October 26, 2022 at \$15.00 per hour. All aye. Motion carried.

Moved by Swisher seconded by Schlarmann to approve a Class C Liquor License, with Outdoor Service and Sunday Sales privileges, for Fawn Creek, Inc., doing business as Fawn Creek Country Club, 1601 130th St., Anamosa, to be effective November 9, 2022. All aye. Motion carried. [2022-170]

The Board discussed replacing trees that were recently taken down in the Courthouse lawn.

Moved by Schlarmann seconded by Rohwedder to approve and place on file the Sheriff's Report of Fees Collected for the quarter ending September 30, 2022. All aye. Motion carried. [2022-171]

The Board reviewed violations of the Jones County Nuisance Ordinance on property owned by Faron Fritz located at 24052 Ridge Rd. E28, Anamosa after a two-week extension was granted.

Moved by Swisher seconded by Schlarmann to abate the nuisance at 24052 Ridge Rd. E28, Anamosa, citing that the property has improved and that the party in possession of the property does need to continue to maintain the property at the current level. All aye. Motion carried.

The Board gave updates on past and future committee meetings and discussed future agenda items.

The Engineer met with the Board to provide updates on the sale of used equipment; options for purchasing lights that caution drivers to follow speed limits; and updates on various projects.

Moved by Schlarmann seconded by Swisher to adjourn the meeting at 10:15 a.m. All aye. Motion carried.
