

Jones County Solid Waste Commission Meeting Minutes

August 1st, 2023

The Jones County Solid Waste Commission meeting was held at the Jones County Courthouse. Those present were Chairman Russ Benke, Ned Rohwedder (Jones Co. Supervisor), Dale Barnes (Anamosa), Dave Dircks (Olin), Wayne Peach (Monticello), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Barnes to approve the minutes from the previous month's meeting. Rohwedder seconded the motion and it passed with all voting Aye.

The expenditures and financial reports were reviewed with Barnes making a motion to approve them. Rohwedder seconded the motion and it passed with all voting ayes.

- C.** The board was updated by Chairman Benke on the contents of a safety deposit box opened at Citizen's State bank.
- D.** Taylor discussed the intention to post an opening for a part-time Operator as well as an On-Call Operator to see which gets more response.

Barnes moved to adjourn, and the meeting was adjourned at 5:35 p.m.
