



Jones County Solid Waste Commission Meeting Minutes

November 7th, 2023

The Jones County Solid Waste Commission meeting was held at the Jones County Courthouse. Those present were Chairman Russ Benke, Ned Rohwedder (Jones Co. Supervisor), Jeff Swisher (Jones Co. Supervisor), Dale Barnes (Anamosa), Dave Dircks (Olin), Wayne Peach (Monticello), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Rohwedder to approve the minutes from the previous month's meeting. Peach seconded the motion and it passed with all voting Aye.

The expenditures and financial reports were reviewed with Barnes making a motion to approve them. Peach seconded the motion and it passed with all voting ayes.

ECICOG: Alicia Presto updated the board on the ongoing planning for future community programs including the Summer Reading Program. She also spoke about the status of the Glass Recycling Program.

New Business:

A. The board discussed what to charge (if anything) for recycling glass. Barnes made a motion to charge the same rate as for trash. Peach seconded the motion and it passed with all ayes.

B. The board reviewed the renewal of the supplemental healthcare plan for Leonard Brokens. A motion to approve was made by Rohwedder with a second from Swisher. The motion carried with all voting aye.

C. The board reviewed the reports from the annual Transfer Station Inspection as well as the Semi-Annual Closed Landfill Inspections. No immediate action was required from the board.

Barnes moved to adjourn, and the meeting was adjourned at 5:25 p.m.
