



## Jones County Solid Waste Commission Meeting Minutes

February 6th, 2024

The Jones County Solid Waste Commission meeting was held at the Jones County Courthouse. Those present were Chairman Russ Benke, Ned Rohwedder (Jones Co. Supervisor), Jeff Swisher (Jones Co. Supervisor), Dave Goedken (Monticello), Wayne Peach (Monticello), Dave Dircks (Olin), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Swisher to approve the minutes from the previous month's meeting. Rohwedder seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Goedken making a motion to approve them. Rohwedder seconded the motion and it passed with all voting ayes.

**ECICOG:** Alicia Presto updated the board on the Environmental Assembly Program and asked for help getting the information to local schools. She also updated the status and progress in the glass recycling program.

### **New Business:**

- A.** After a brief discussion about where we need to start new employees' pay, and the corresponding impact on current employees, a motion was made by Rohwedder to increase Dean Husman's rate to \$21.50 hr. and start new hires at \$18 hr. with an increase to \$19.00 after a 90-day probationary period. Goedken seconded the motion and it passed with all voting ayes.
- B.** Taylor asked for advice on what procedural steps had to be followed in hiring a new operator. Presto agreed to check out exactly what the requirements were before any offers were made. Providing all necessary steps were followed it was left to Taylor's discretion whom to hire.
- C.** After reviewing the costs involved, it was decided that in the immediate future the transport of HHM to Linn County Landfill will be performed by the Linn County Solid Waste Agency on a fee basis.

Peach moved to adjourn, and the meeting was adjourned at 5:40 p.m.
