

## **D. RULES & STIPULATIONS:**

**1. Cleaning/Damage DEPOSIT FEE REQUIRED:** A fifty (\$50.00) refundable damage deposit fee is required at the time of reservation. This fee will be returned by mail upon satisfactory inspection of the facility following your departure. This fee will cover any extra cleaning and/or cost of lost keys. The damage deposit should be made by check and made out to the Jones County Conservation Board. Please note "damage deposit" in the memo line of your check. Upon inspection, any damage to the facility, inside or out, will be assessed to the signed group representative. Fees assessed for damages above and beyond the \$50 damage deposit will be charged to the signed group representative.

### **2. Cabin Rental Fees:**

Sunday – Wednesday Evenings: \$30 for the first night. \$25 each additional night.

Thursday – Saturday Evenings: \$35 for the first night. \$30 for each additional night.

A 10% Excise/Hotel/Motel Tax is required on your total cabin rental fee.

Payment by check should be made out to the Jones County Conservation Board. Please write "cabin rental fee" in the memo line of your check.

No reservations are valid until payment and deposit are received.

**3. Check-in time is 4 PM** on the date of arrival.

**4. Check-out time is Noon** on the date of departure.

5. This reservation permit is not transferable or refundable.

**6. Park quiet hours are 9 PM – 8 AM. The park closes to visitors and traffic at 10:30 PM.**

**7. ABSOLUTELY NO SMOKING** allowed inside the cabins. Violation of this rule automatically forfeits refund of the damage deposit.

**8. Pets:** Pets are not allowed inside the cabins. Only one pet is permitted per reservation group. Pets must be on a six foot leash at all times. Violation of this rule automatically forfeits refund of the damage deposit. Groups with a pet kept outside are required to pick up and dispose of pet waste upon departure.

**9. CARRY IN/CARRY OUT:** In an effort to keep your parks clean all refuse shall be removed from the premises by the occupying group at the end of their stay.

**10. Cabin Keys:** The signed group representative shall pick up and return the cabin key to the campground host upon arrival and departure unless other arrangements have been made with park staff.

**11. Tents:** One small tent (less than six person capacity) is permitted for each cabin. The tent must be set up within 30 feet of the reserved cabin and be at least 30 feet away from the other rental cabin.

**12.** Failure to comply with park rules, or valid complaints about your group during your stay, will prevent future reservations from being issued and serve as cause for revocation of this permit, and the entire group shall be required to vacate the premises.

**13. Furnishings:** Each cabin includes electricity, a ceiling fan, a futon or sofa sleeper, bunk bed, table and chairs, dorm sized refrigerator, small microwave, small storage closet, broom and dust pan, picnic table, and fire pit with grill. Users will need to provide their own bedding, personal items, service wear, cooking utensils, and cleaning supplies.

**14. Usage Dates:** Cabins are available for rent from April 15 thru October 15. Reservations are taken beginning the first of each calendar year.
