Certificates of insurance from the competent fireworks operator, the sponsoring organization or applicant, and the owner of the property where the fireworks display will be conducted. Said certificates of insurance shall list Jones County as a primary additional insured on the respective general liability policies. Each certificate of insurance shall display minimum liability limits of \$1,000,000 per occurrence, \$2,000,000 aggregate.

File completed application and insurance certificates in the Jones County Auditor's Office no later than 9:00 a.m. on the day prior to the Board of Supervisors meeting when the application is to be considered.

Jones County Fireworks Permit Policy on back.

Jones County Fireworks Permit Policy

Pursuant to Iowa Code section 727.2, the Jones County Board of Supervisors may, upon written application, issue fireworks permits only to municipalities, fair associations, amusement parks, and other organizations or groups of individuals, when the fireworks display will be handled by a competent operator. The Code of Iowa provides penalties for fireworks displays conducted without said permit. The term “fireworks” shall be as defined in Iowa Code section 727.2, as now or hereafter amended.

Applicants for a permit to display fireworks in rural Jones County shall provide the following information on a form obtained from the office of the Jones County Auditor:

- Name and address of applicant.
- Date of the permit application.
- Name and address of organization sponsoring the fireworks display.
- Location and date of fireworks display.
- Expected number of attendees at proposed event.
- Name and address of the competent fireworks operator who will be handling the display.
- Written approval of the chief of the local fire department that provides fire protection to the location of the fireworks display.
- Signatures from each of the following:
 - applicant
 - president of the sponsoring organization
 - property owner for the location of the fireworks display
 - competent fireworks operator who will be handling the display
- Attached to the completed application shall be certificates of insurance from the competent fireworks operator, the sponsoring organization or applicant, and the owner of the property where the fireworks display will be conducted. Said certificates of insurance shall list Jones County as a primary additional insured on the respective general liability policies. Each certificate of insurance shall display minimum liability limits of \$1,000,000 per occurrence, \$2,000,000 aggregate.

Completed applications and attachments shall be filed in the Jones County Auditor’s Office no later than 9:00 a.m. on the day prior to the Board of Supervisors meeting when the application is to be considered.
