

Jones County Solid Waste Commission Meeting Minutes

May 7th, 2024

The Jones County Solid Waste Commission meeting was held at the Jones County Courthouse. Those present were Chairman Russ Benke, Will Roller (Morley), Wayne Peach (Monticello), Dave Goedken (Monticello), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Roller to approve the minutes from the previous month's meeting. Goedken seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Goedken making a motion to approve them. Roller seconded the motion and it passed with all voting ayes.

ECICOG: Alicia Presto updated the board on the Environmental Assembly Program as well as the RFP process for white goods.

Old Business:

New Business:

A. Presto presented the board with the framework for modifying the policy of mandatory half-hour lunch breaks. Updated language will be added to the SWMC Employee Handbook for approval at the June Meeting.

B. The board reviewed draft language to implement a 1.5 % late fee on accounts that are 60 days past due and freezing accounts that are 90 days past due until payment arrangements are made. Goedken made a motion to approve this policy effective July 1 2024. Roller seconded the motion and it passed with all ayes.

C. The board reviewed the bid for upcoming audits from the office of the State Auditor and approved it as there were no other bidders.

D. Taylor informed the board about losses taken in tire disposal over the last three years. This was due in a large part to water from being stored outdoors and dirt and gravel from the loading process. Taylor was tasked with putting together more detailed numbers to be factored in along with the updated Liberty Tire contract to be addressed at the June Meeting.

E. Taylor informed the board about the need to replace tires on the TM420 end loader in the future if it is to continue as the primary loader in operation.

Peach moved to adjourn, and the meeting was adjourned at 5:35 p.m.
